



Leader ALC Spearheads **Medical Donations** and Support to Help Fight Wuhan Coronavirus







to distribute direly needed medical supplies to hospitals throughout China

American Lending Center (ALC), in partnership with its sister company Sunstone Management, have begun a series of donations to help mitigate the spread of the coronavirus. With the total number of confirmed cases above 28,000 and those in the US rising daily, the declared global health emergency requires a global response. ALC is the first EB-5 regional center and Sunstone is the first U.S. investment firm to send aid to be distributed among hospitals in China, collaborating directly with Chinese government officials, hospital facilities and transport services.

Medical supplies have become so limited in China that basic needs can be too expensive for hospitals to afford, with one face mask going for up to \$30 USD and delivery delayed by up to two months, ALC and Sunstone's initial donation, which arrived in Beiling for distribution across China on February 3, included 17,000 masks for six hospitals. The medical facilities receiving supplies are two hospitals in Jingzhou, one in Nanzhang, and one in Huangmei - all in Hubei Province surrounding the City of Wuhan - as well as hospitals in Beijing and Chongqing.

ALC and Sunstone will continue to support efforts to halt the rapid spread of the disease by facilitating further donations of medical clothing, devices and other important supplies















Marrying EB-5 with SBA lending created a unique opportunity for emigrating investors

At the height of the Great Recession, strepreneur John Shey had all of \$7 in his back account and a family of four to fired. Income from his thriving Florida real estate bashwesses, which had been growing steadily, was suddenly gone. By 2009, Shen had lost his company and struggled with seemingly ntable personal debts.

Having faced hard times before, "Linew T had the ability to come back! Shen save. He grew up in China, attended graduate

school in the 519, then spent eight years as a successful pharmacoutical professional before deciding that starting his own business was his best strategy for prospecity.



A new correpreneurial opportunity surfaced that same year, in 2009, when President Barack Obania signed legislation to jump start the faltering economy. Shen studied the legislation and found appartunities to belp small birginesses.

He was already familiar with the federal Ris-5 capital program, which was started in 1990 to attract investment in U.S. companies. EB-5 was established to allow up to 10,000 foreign citizens annually to receive a green. card and permanent resident scattes in exchange for an investment of \$900,000 in U.S. compunies

Those investment funds help fuel growth in U.S. businesses and create new American Jobs. A 2019 report found that EB-5 investment programs, in total, contribuned more than \$35 billion to the U.S. economy between 2014 and 2015, through more than 75,000 construction jobs.

In July 2009 Shen submitted his first regional senter business proposal to the U.S. Citizenship and Immigration Services (USCIS) under Homeland Security. This unique business model injected the EII-5. capital into U.S. small businesson through SBA 504 loans. In April 2010, his propina was approved.

To connect high-net-worth Chinese citizens with the apportunity to invest in 1.8 horinesses, Shen established Regional Centers Holding Group (RCH) in 2012, Since its founding, RCH has grown to include (2) regional centers designated by the USCIS to facilitate EB-5 investments.

"It took three or four years to build the infrastructure, and then the market took off in-2015" Shed ages.

Many of the investments were made through the SBA 504 loan program in the hospitality industry, with new hosel construction, assisted living facilities, medical offices, cinemas, and manufacturing, he says.

Bi. H was so successful that Shen was mmed "SRA 504 Lander of the Vear" by Coleman Report in 2017.

The market has occupily cooled, due to the plabal pandennie and changing government policies, he says, so REH pivoted. The company is one of only two nonbanks to provide Paycheck Protection Program (PPP) loans. "which says a lot about our credibility," Shen says.
